ARPA Board of Directors Meeting Kentucky Beef Expo - Louisville, Kentucky Minutes of March 2, 2018

The meeting was called to order on Friday, March 2, 2018 at 6:00 pm EST by President Mike Reed

Roll call was done. Those in attendance were President Mike Reed, VP Brian Fairchild, Jim Jackson, Daniel Schmiesing, Kyle Young, John Rager, Chet Miller, J.L. Morrison, Teresa Jackson, and Kaye Gilbert. Attending by phone were Dan Womelsdorf and Jeff Wilkins.

Mike Reed asked for a motion for the agenda as presented. Dan Schmiesing requested the Secretary's report be moved to immediately after the Approval of Minutes. Brian Fairchild requested to move the hiring of the secretary to be after the Secretary's report but before the Committee report. Dan Schmiesing made a motion to amend the agenda with those changes. Kyle Young made a motion to allot \$2500 to the North American in 2018 as needed to fund the 2018 National Show. A second was given by Dan Schmiesing. Motion carried.

Teresa Jackson handed out the Junior Committee report. She asked ARPA for a contribution to the Junior Preview show. Last year ARPA provided postage for the mailing of donation solicitations. No action was taken at this time.

Brian Fairchild and Kyle Young gave the National Sale report. They are currently working on advertising as well as booking auctioneers. Kaye volunteered to give the committee her contacts and information from when she has conducted sales in the area.

Dan Schmiesing made a motion to accept all committee reports as presented. A second was given by Jim Jackson. Motion carried.
